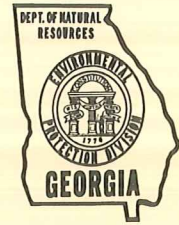

**MODIFIED CONDITIONS**

- 2.1 Approval to construct shall become invalid if construction is not commenced by **April 14, 2016**, if construction is discontinued for a period of 18 months or more, or if construction is not completed within a reasonable time. The deadline for commencing construction will be extended beyond April 14, 2016 for the number of days Permit 4911-303-0051-P-01-3 is stayed by the filing of a petition for hearing by a party other than the Permittee, or by other stay as ordered by a court of competent jurisdiction. For the purposes of this Permit, the definition of "commence" is given in 40 CFR 52.21(b)(9).

**NEW CONDITIONS**

- 8.4 Prior to beginning actual construction, the Permittee shall submit to the Division an analysis demonstrating that the plant, as permitted, will not cause or contribute to air pollution in violation of the National Ambient Air Quality Standards listed in items a-c below. The Division reserves the right to approve or disapprove the submitted analysis.
- a. NO<sub>2</sub> – 1 Hour standard effective April 12, 2010
  - b. SO<sub>2</sub> – 1 Hour standard effective August 23, 2010
  - c. PM<sub>2.5</sub> – Annual standard effective March 16, 2013
- 8.5 All reference to 40 CFR 63 Subpart B in Permit No. 4911-303-051-P-01-0 and its amendments are hereby revoked. The Condition requirements themselves remain applicable unless otherwise noted in this permit amendment.
